## THIS APPLICATION SHOULD BE SUBMITTED WITH

- Two (2) recent, identical passport photos (less than 6 months old). The Identity Witness must write the applicant's full name on the back of one photo, and sign and date the back of the photo.
- Copy of Original Vanuatu birth certificate
- Copy Married Certificate (women only)
- Previous Vanuatu Passport
- The appropriate fee (VT) for the service required:
  - ♦ 0 to 5 years old 5,000
  - ♦ 6 to 17 years old 7,000
  - ♦ Normal 10,000 (up to 21 days processing time)
  - Express 20,000 (up to 10 days processing time)
  - ♦ Urgent 25,000 (up to 3 days processing time)
- Original birth and citizenship certificate(s) as specified in the Citizenship Declaration section
